The Australian College of Nursing (ACN) continues to have an interest in issues relating to stroke regularly providing updates and information to members directly and indirectly relating to stroke. In this reporting period ACN has made the following notifications:

ACN provided feedback when asked to comment on specifically tailored data variables to be used in NSW which have been approved by The AuSDaT Coordinating Committee.

Describe a specific challenge that you, or your organisation is facing. Ideally this will relate to stroke, or if that is not possible, be relevant to health and care professionals.

ACN continues to advocate for a minimum requirement of having a registered nurse (RN) on duty at all times in residential aged care facilities to promote safety and well-being for all residents. ACN actively supports the position that consumers with high care needs (including those who have had or are at risk of stroke) require the expertise of an RN to provide frontline leadership in the delivery of nursing care to ensure timely access to effective nursing assessment and comprehensive nursing care, and to the evaluation of that care.

ACN continues to endorse the NACA Position Statement 'Enhancing the quality of life of older people through better support and care' included in the NACA Blueprint which promotes securing access to affordable assistive technologies, aids and equipment.

ACN continues to advocate for the need for rehabilitation and ongoing care for stroke survivors, the need for data collection and quality improvement and access to quality care for all Australians including an ASC focus on equity of access to rehabilitation for all stroke survivors.

ACN continues to offer a flexible and well supported Community and Primary Health Nursing graduate certificate. This distance education course is accredited by the Tertiary Education Quality Standards Agency and addresses contemporary patient care strategies and professional nursing issues associated with chronic disease management for conditions such as stroke.

In particular, a Chronic and Complex Care subject was re-designed in 2016 to cater for nurses working in community settings, long term care and rehabilitation facilities. The curriculum highlights strategic needs assessment and long term management options that form the basis for achieving better patient health literacy and self-caring skill.

Through this unit of study, nurses examine the impetus for change in conventional health service delivery to realign community care and improve health outcomes for people with chronic diseases including stroke and other neurological disorders. Students explore themes focused on management of clients by critiquing models of care and collaborative case management, as well as bioethical, psychosocial and community issues related to chronic and complex disease management.
