

Safe.

- Nurses, nurse practitioners, and midwives are safe and regulated, and their care leads to quality patient health outcomes.
- Protected titles: Nurse and Midwife are protected titles requiring specific training.
- Regulated by government: The professions are regulated by the Nursing and Midwifery Board of Australia (NMBA) and the Australian Health Practitioner Regulation Agency (AHPRA).



Only **0.5%** of nurses had a notification to NMBA/AHPRA in 2022/23, compared to 5.6% of all medical practitioners.

- Australian nurses and midwives have an average age of 43 and 47 years, respectively.
- Nurses typically work in more than three clinical settings, gaining valuable experience.
- Nurses bring a wealth of experience, with a median of 21 years in the profession.
